

# Forest Journey

Conserving Biodiversity in Productive Landscapes



The **Forest Journey** explores the growing demands put on forests, such as biodiversity conservation, climate change mitigation and income generation and illustrates how rights based approaches to managing forested landscapes offer best case scenarios. Recognizing that governance issues are at the heart of many forest management problems, the **Forest Journey** looks at balancing forest productivity with

changing agricultural demands, how proposals to exploit forests for sequestering and storing carbon might work for forest communities and how we can help these same communities adapt to climate change. The tools used to capture peoples' hopes for improving their landscapes and monitoring changes are highlighted and the role markets play in meeting local needs whilst sustaining biodiversity are assessed.

We hope that the **Forest Journey** provides new ideas and new ways of looking at old ideas that can be taken back to the landscapes in which the IUCN membership works. We look forward to travelling with you on the **Forest Journey** and meeting you at the Forest Pavilion.
